

Erowid's Anonymous Laboratory Drug Checking Project



A Right To Know What's In Your Drugs

DrugsData Project Overview

Since 2001, Erowid Center has operated a laboratory drug checking project. Samples are submitted anonymously through the mail by the public directly to our DEA-licensed lab.

- Lab testing using GC/MS plus four reagent tests.
- Row by row data published for each sample.
- Testing for the public and resarch partners.
- Turnaround time 2–5 weeks.
- No quantitative results (qualitative only)
- 11,623 samples analyzed and results published since 2001. 6,463 in the last 3 years.

Confirmatory Testing for Research Partners

Starting in 2020, Erowid began parntering with front-line harm reduction groups, to do laboratory confirmatory testing for samples of opioids, methamphetamine, and cocaine.

- 3,172 confirmatory tests conducted
- Row by row data published for each research sample, as with all public samples
- To help identify extent of fentanyl and other super-potent opioids in drug markets
- To check accuracy of point-of-care technologies such as FTIR and fentanyl or benzo test strips
- To help evolve technology developments
- To help validate front-line technician training
- To promote accesss to drug-checking services for the public and improve government policies

Ongoing Research

- We are working with research partners to analyze and publish about our results.
- Outside resarchers must request permission to publish results or analysis.

Submission Details

- We accept tablets, powders, and baggies with residue.
- Ideal sample size is 10 mg.
- Secure packaging is required for mailing.
- Submission instructions can be found at DrugsData.org/send
- Testing requires a \$100–\$200 co-pay.
